CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION AND BY-LAWS OF THE OF POMPANO BEACH CLUB NORTH

The undersigned officer of POMPANO BEACH CLUB NORTH, A CONDOMINIUM ASSOCIATION, INC., a Florida not-for-profit corporation, whose original Declaration of Condominium having been recorded in Official Records Book 6380, Page 857 of the Public Records of Broward County, and subsequently amended, do hereby certify that this Amendment to the Articles of Incorporation and Amendment to the By-Laws of Pompano Beach Club North, a Condominium, were approved and adopted by the requisite number of owners in the Condominium at a duly called meeting on August 29, 2022. The undersigned further certify that the Amendments to the Articles of Incorporation and By-Laws were adopted in accordance with the condominium documents and applicable law.

(New language is indicated by underscored type; deletions by strikeout)

1. Article IX of the Articles of Incorporation shall be amended as follows:

Article IX - Amendments

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- 1. Notice of the subject meeting matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 2. A resolution approving a proposed amendment may be proposed by either the Board of Directors, or by any one or more members of the Association. Directors, and members not present in person, or by proxy, at the meetings considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary of the Association at, or prior to, the meeting.
 - (a) Such approval must be by not less than a simple majority of the entire membership of the Board of Directors, and by not less than <u>sixty-six and two-thirds (66,6%) of the Members present and voting at a meeting (in person, by proxy or electronically) sixty (60%) percent of the votes of the entire membership of the Association; or</u>
 - (b) If the majority of the Board of Directors does not approve the proposal, then by not less than sixty (60%) percent of the votes of the entire membership of the Association, provided, however that the costs associated with such solicitation shall be borne by those members proposing the amendment.

2. Section 8 of the By-Laws shall be amended as follows:

- 8. Amendments: These Bylaws may be amended in the following manner:
 - 1 Notice of the subject matter of the proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
 - .2 A resolution adopting a proposed amendment may be proposed by either the Board of Directors of the Association or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided, such approvals must be by either
 - (a) Not less than a simple majority of the entire membership of the Board of Directors and by not less than <u>sixty-six and two-thirds</u> (66.6%) of the Members <u>present and voting at a meeting (in person, by proxy or electronically) sixty</u> (60%) percent of the votes of the entire membership of the Association; or
 - (b) If a majority of the Board of Directors does not approve the proposal, then by not less than sixty (60%) percent of the votes of the entire membership of the Association, provided, however that the costs associated with such solicitation shall be borne by those members proposing the amendment; or
 - (c) By all of the directors, until the first election of directors.
