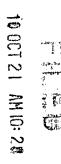

ARTICLE IX

Disposition of Real Property: Except as herein provided, the Board of Directors of the corporation shall not be authorized to dispose of any of the real properties owned by the corporation except by approval of member vote. The quorum for any meeting of members called to take action with regard to disposition of corporation real estate shall be the presence of members, or of proxies, constituting not less than 60% of all members entitled to vote. If the first meeting duly called for such purpose fails to produce the required quorum, a second meeting may be duly noticed and called at which the quorum shall be 30% of the members entitled to vote, provided that such subsequent meeting shall be held not more than sixty (60) days following the preceding meeting. The proposed action shall be approved by two-thirds vote of the member voting at a meeting at which a quorum is present. The Board of Directors, without members vote, may authorize granting of utility easements or parcels necessary for use in connection with furnishing of services for the benefit of the members. The Board of Directors may also, without members vote, authorize the disposal of real property acquired by the corporation, pursuant to Section 720.3085 Florida Statutes or other collection methods, (continued on attachment page)
