

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
CIVITAN REGIONAL BLOOD CENTER, INC.**

Civitan Regional Blood Center, Inc., a Florida not-for-profit corporation, incorporated under Chapter 617, Florida Statutes, known as the "Florida Not-For-Profit Corporation Act" does hereby adopt the following Articles of Amendment to its Articles of Incorporation pursuant to Section 617.1006, Florida Statutes, and Article X of its Articles of Incorporation:

First, Article I of the original Articles of Incorporation is hereby amended in its entirety to read as follows:


"Article I  
NAME


The name of this corporation shall be LIFESouth Community Blood Centers, Inc. By prior agreement with Civitan International, the corporation continues to have the right and license to the use of the names "Civitan Regional Blood Center" and "Civitan Regional Blood System" and the Civitan logos within the Florida district of Civitan International, and the corporation may, in the discretion of the Board of Directors, continue to use the names "Civitan Regional Blood Center" and "Civitan Regional Blood System" together with the Civitan logos as registered fictitious names within the State of Florida, as more fully set forth in the license agreement dated October 22, 1996, between the Corporation and Civitan International. The use of the Civitan name, emblem, insignia, and other paraphernalia appertaining in any way to Civitan International may be discontinued should the Corporation cease to be affiliated with or sponsored by a Civitan club and as otherwise provided in the license agreement."

Second, the effective date of the adoption of these Articles of Amendment is March 25, 1997.

Third, these Articles of Amendment were approved by the members entitled to vote thereon on March 25, 1997, and the number of votes cast for the amendment were sufficient for approval.
