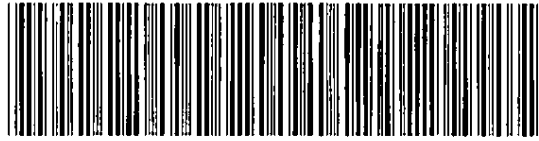

ARTICLES OF INCORPORATION
OF
BOCA RATON CHURCH OF CHRIST, INC.

(A Corporation Not for Profit)

WHEREAS, the Citizens of Boca Raton, Palm Beach County, Florida, and surrounding areas are interested in providing spiritual guidance in Boca Raton for the benefit and welfare of the area; and,

WHEREAS, the cost of building a Church, ^{building} furnishing necessary supplies, fixtures, equipment and services cannot be provided by any given person, or group of persons;

NOW, THEREFORE, We, the undersigned, do hereby associate ourselves together for the purpose of forming a non-profit corporation under those laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation not for profit, including those granted by Chapter 617, Florida Statutes, 1957, as amended by Chapters 59-427, Laws of Florida, Acts of 1959, and Chapter 69-106, Laws of Florida, Acts of 1961.

ARTICLE I

The NAME of this corporation shall be:

BOCA RATON CHURCH OF CHRIST, INC.

ARTICLE II

The PURPOSES AND OBJECTS for which this corporation is organized and the general nature of the business to be transacted shall be:

(a) To have all the powers mentioned in Section 617, Florida Statutes;

(b) To receive and hold by gift, bequest, devise, grant or purchase any real or personal property, and to invest and reinvest, and to use and dispose of the same for the purposes of providing Church facilities, for the meeting of its members in public worship, for its work of preaching and teaching the Word of God, including both the educational and benevolent

work of said Church of Christ in accordance with its tenets of faith and practice; and in general to do all things that may appear necessary and useful in accomplishing the purposes hereinabove set out; except that no part of the net earnings or income shall enure to the benefit of, to, or be distributed to its members, directors, officers and/or any private shareholder or individual; and that no substantial part of its activities shall be the carrying of propaganda or otherwise attempting to influence legislation;

(c) To act and perform the duties of trustee or to act in any other fiduciary capacity under any deed of trust, will, codicil, agreement, whether oral or written, or other instrument incidental to and for the purpose of carrying out any of the foregoing objects or matters and things kindred thereto.

The objects and purposes specified in the foregoing clauses of this ARTICLE II shall, except where otherwise expressed in this Article, be in nowise limited or restricted by reference to, or inference from, the terms of any other clause of this or any other Article of these Articles of Incorporation, but shall be regarded as independent objects and purposes and shall be construed as powers as well as objects and purposes.

ARTICLE III

The MEMBERSHIP of the corporation shall consist of the following:

- (a) The individuals constituting the Board of Trustees hereinafter provided, and their successors in office;
- (b) Members of the BOCA RATON CHURCH OF CHRIST, INC., in full fellowship with said Church, have been received into its membership, and who subscribe both in theory and practice to the tenets of faith which identify said Church in its distinct and unique position and character.

ARTICLE IV

The corporation shall have perpetual existence.

ARTICLE V

The names and post office addresses of the subscribers to these Articles of Incorporation are as follows:

ARTICLE VI

Subject to overall supervision of the Board of Trustees of the corporation, and to any special provisions of the By-Laws of the corporation, the affairs of the corporation are to be managed by the following officers (who will be elected at the Annual Meeting of the said Board of Trustees to be held at such time as may be determined by the By-Laws):

President
One or more Vice Presidents
Secretary, and
Treasurer.

The office of Secretary and Treasurer may be held by one person.

ARTICLE VII

ARTICLE VIII

(a) The business of the corporation shall be under the overall supervision of its BOARD OF TRUSTEES.

(b) The First Board of Trustees, who shall serve until January 2, 1975, or until their successors shall be appointed and qualified as provided

in ensuing sub-paragraph "c" of this ARTICLE VIII shall be as follows:

(c) Beginning January 2, 1975, the Board of Trustees shall be composed of not less than five (5) and not more than ten (10) persons, as may be fixed from time to time by the By-Laws. The terms of these Trustees shall be for one (1) year. Such Trustees shall be elected by an affirmative vote of a majority of members of the Church. Vacancies occurring during a term shall be filled for the unexpired portion thereof, as prescribed in the By-Laws.

ARTICLE IX

The By-Laws of the corporation shall be made, altered or rescinded by two-thirds (2/3) vote of the members present at a meeting which has been called for that purpose.

ARTICLE X

Amendments to these Articles of Incorporation shall be approved by majority vote of the said Board of Trustees, proposed by the said Board to the membership, approved and adopted by two-thirds vote of the membership of the corporation and filed with and approved by the Secretary of State of Florida.

ARTICLE XI

Title to Property

The title to all property of the corporation shall be held in the name of the corporation or as otherwise may be provided pursuant to the authority of the charter and By-Laws of the corporation. Any gift, bequest, devise or donation of any kind whatsoever to the corporation or its Board of Trustees shall be deemed to vest title in the corporation.

ARTICLE XII

Seal

The seal of the corporation shall be inscribed with the following words: "BOCA RATON CHURCH OF CHRIST, INC." , and the seal shall include the words, "A Florida non-profit corporation".

ARTICLE XIII

Meetings

The meetings of said Board of Trustees shall be at such time as shall be set forth in the By-Laws.

ARTICLE XIV

Dissolution

In the event of dissolution or final liquidation, all property, real or personal, then belonging to the corporation, shall be paid and distributed, after taking care of the claims of creditors and the costs of the proceeding, if the Circuit Judge in his discretion so directs, to religious, charitable and/or educational organizations, exempt from taxation under Sections 501 (a) and (c) (3) of the Internal Revenue Code of 1954.
