# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF COLLIER PREGNANCY CENTERS, INC.

### ARTICLE I NAME

The name of the corporation is **COLLIER PREGNANCY CENTERS**, **INC.** The principal place of business and mailing address of the corporation shall be 970 5<sup>th</sup> Avenue N., Naples, Florida 34102.

### ARTICLE II PURPOSE

The purpose of this corporation shall be to engage in charitable purposes within the meaning of Section 501(c)(3) of the Internal Code of 1996, as amended, and any corresponding section of any future federal tax code (the "Code").

## ARTICLE III METHOD OF ELECTION OF DIRECTORS

The number of Directors constituting the initial Board of Directors shall be three (3). Directors shall be elected or appointed in the manner and for the terms provided in the Bylaws of the corporation. The number of Directors may be increased or decreased from time to time by amendment to or in the manner provided in the Bylaws, but the corporation shall never have fewer than three (3) Directors.

### ARTICLE IV MEMBERS

There are no members of the corporation entitled to vote. The membership of this corporation and the manner of admission, if any, shall be set out in the Bylaws of the corporation.

The corporation shall indemnify the Officers and Directors of the corporation as provided for in the Bylaws of the corporation.

### <u>ARTICLE VI</u>

The street address of the registered office of this corporation is 970 5th Avenue N., Naples, Florida 34102 and the name of the initial registered agent of this corporation at that address is RENEE S. BECKNER.
