

Purposes

The general nature, objects and purposes of the Association are:

(i) To provide, at the Board of Directors' sole and absolute discretion, community association management services to the individual residential condominiums, Lots and Parcels in Indian Spring based on criteria established by the Board from time to time.

(ii) To either obtain a license as a community association management company pursuant to Chapter 468, Florida Statutes (2011), or to create a separate corporate entity for the purpose of providing community association management services to the residential condominiums, homeowners associations, Lots and Parcels based on criteria established by the Board from time to time.
