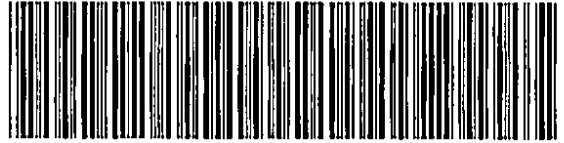

Your records do not reflect this change, that is the reason I am correcting them myself.


