# SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION AHA OF PALM BEACH DAY SCHOOL

## 733403

Palm Beach Day School, formerly known as Palm Beach Private School (the "Corporation"), a not for profit corporation organized and existing under and by virtue of the Florida Not For Profit Corporation Act (the "Act"), does hereby certify that:

- 1. The original Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on May 3, 1931, and Amended and Restated Articles of Incorporation were filed with the Secretary of State of the State of Florida on November 9, 1999.
- 2. The Second Amended and Restated Articles of Incorporation set forth herein have been duly approved at a meeting duly held by the Board of Trustees on May 31, 2006 in accordance with Sections 617.1007 and 617.1006 of the Act and the number of votes cast were sufficient for approval. The Corporation has no members.
- 3. The Articles of Incorporation of the Corporation are hereby amended and restated, effective as of 12:01 a.m. on July 1, 2006, as follows:

## ARTICLE I

The name of the Corporation shall be: Palm Beach Day Academy, Inc.

## ARTICLE II

The principal place of business and mailing address of the Corporation shall be:

241 Seaview Avenue Palm Beach, FL 33480

### ARTICLE III

This Corporation is organized for the purpose of forming a scientific institution of learning which shall include the operation of private scientific schools, colleges or other

institutions of learning and a library, including all of the activities usually and generally associated with the above named objectives and to have the authority to charge and receive payment for the services rendered. The Corporation shall have full power to receive, own, lease, buy, sell or mortgage real or personal property of every nature whatsoever which may be necessary, usual or convenient for the transaction of its business and the accomplishment of the purposes of this organization.

## ARTICLE IV

The manner in which the Board of Trustees of the Corporation are elected shall be specified in the Bylaws of the Corporation. The Corporation shall have no members.

### ARTICLE V

The Corporation shall have a perpetual existence.

### ARTICLE VI

This Corporation shall indemnify its Trustees and officers and may indemnify its employees, agents and such other persons as designated by a majority of the Trustees, to the fullest extent permitted by the Act and the Florida Business Corporation Act, as the same may be amended and supplemented, from and against any and all of the expenses or liabilities incurred in connection with a civil or criminal proceeding brought against such person or other matters referred to in or covered by said provisions including advancement of expenses prior to the final disposition of such proceedings and amounts paid in settlement of such proceedings, both as to action in his or her official capacity and as to action in any other capacity during such relationship with this Corporation. The indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified persons may be entitled under any other law, by-law, agreement, vote of disinterested Trustees or otherwise. This indemnification shall continue as to a person who has ceased to be a Trustee, officer, employee or agent, and shall

inure to the benefit of the heirs, personal representatives and administrators of such a person. An adjudication of liability shall not affect the right to indemnification for those indemnified.
