## Literacy Services of Indian River County, Inc. Approved Amendments to the Articles of Incorporation

Change the title to say ARTICLES OF INCORPORATION OF LITERACY SERVICES OF INDIAN RIVER COUNTY, INC., as reflected in the Amendment to the Articles filed February 14, 2003.

ARTICLE I - NAME: Change the name to say LITERACY SERVICES OF INDIAN RIVER COUNTY, INC.

ARTICLE IV – MEMBERSHIP: Delete this Article since the By-Laws, Article I, says that LSIRC is a Florida not-for-profit corporation without members.

ARTICLE VII – OFFICERS: Delete "a Secretary" and "a Tutor Coordinator" to be consistent with the By-Laws.

ARTICLE IX – BY-LAWS: Change "by a majority vote of those members of the Corporation" to "by a two-thirds vote of those members of the Board of Directors" to be consistent with the By-Laws.

#### ARTICLE X - AMENDMENT

SECTION A: Change "membership" to "Board of Directors". Change "by a 51% vote of those present" to "by a two-thirds vote of those present."

SECTION B: Change "membership" to "Board of Directors".
