SECOND ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF



HAMILTON HOUSE CONDOMINIUM APARTMENTS, INC

Pursuant to the provisions of the Florida Not For Profit Corporation Act, Chapter 617 Fla. Stat. (1999), Hamilton House Condominium Apartments, Inc., adopts the following Articles of Amendment to the corporation's Articles of Incorporation, and states as follows:

FIRST: The name of the corporation is HAMILTON HOUSE CONDOMINIUM APARTMENTS, INC.

SECOND: The corporation adopted an amendment to its Articles of Incorporation, specifically amending Article V, entitled "Directors", Section "A" (page 3) as follows (the language added is <u>underlined</u>; the language deleted is <u>struck out</u>):
