**ARTICLE 1
NAME AND ADDRESS**

The name of this corporation shall be THE FIRST CHRISTIAN CHURCH OF FORT MYERS, FLORIDA, INC. The principal business address of the corporation is 2061 McGregor Boulevard, Fort Myers, Florida 33901.

**ARTICLE 2
DURATION**

This corporation was incorporated on April 13, 1976, and shall have perpetual existence thereafter.

**ARTICLE 3
PURPOSE**

The general nature of the objects and purposes of this corporation shall be:

1. To maintain an organization for the practice and enjoyment of Christian services and duties, and for the converting of the world to Christ.
2. To do any and all things necessary and appropriate in connection with the foregoing purpose and incidental thereto.
