#### ARTICLE XI.

This corporation shall have all of the powers set forth in Florida Statute 617.021, <u>as amended or renumbered from time to time</u>, all of the powers set forth in the Condominium Act of the State of Florida, <u>as amended or renumbered from time to time</u>, and all powers granted to it by the Declaration of Condominium and Exhibits annexed thereto, <u>as amended from time to time</u>.

#### ARTICLE XII.

There shall be no dividends paid to any of the members, nor shall any part of the income of the corporation be distributed to its Board of Directors or Officers. In the event there are any excess receipts over disbursements, as a result of performing services, such excess shall be applied against future expenses, etc. The Corporation may pay compensation in a reasonable amount to its members, directors and officers, for services rendered (other than service as a Director, officer or committee member), may confer benefits upon its members in conformity with its purposes, and upon dissolution for final liquidation, may make distribution to its members as is permitted by the Court having jurisdiction thereof, and so such payment, benefit or distribution shall be deemed to be a divided or distribution to income.

Membership in the Corporation and the transfer thereof, as well as the number of members, shall be upon such terms and condition as provided for in the Declaration of Condominium and Bylaws. The voting rights of the owners of parcels in said Condominium property shall be as set forth in the Declaration of Condominium and/or Bylaws.
