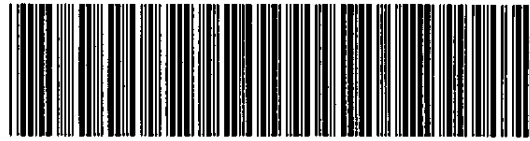

**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF
CRANE'S ROOST VILLAGE CONDOMINIUM ASSOCIATION, INC.**

Pursuant to the provisions of §617.1006, *Fla. Stat.*, CRANE'S ROOST VILLAGE CONDOMINIUM ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article XIII of the ARTICLES OF INCORPORATION OF CRANE'S ROOST VILLAGE CONDOMINIUM ASSOCIATION, INC. ("Articles of Incorporation") is hereby amended as follows (additions are indicated by underlining; deletions are indicated by ~~strike-outs~~, omitted and unaltered provisions are indicated by ellipses):

...

ARTICLE XIII

These Articles of Incorporation may be amended by ~~a vote of two-thirds (2/3) of the members of the Association, which may be accomplished at any regular or special meeting of the members of the Association; provided that written notice of the proposed amendment shall have been mailed to each member not less than fourteen (14) days prior to the meeting at which such amendment will be considered. Articles I, II, III, V and VI may not be amended except by the unanimous approval of all institutional mortgagees (as defined in the Declaration) holding valid and enforceable first mortgage liens on units in the condominium or on any other portion of the condominium property.~~ the affirmative vote of a majority of the members of the Association who are voting in person or by proxy at a meeting of the members at which a quorum has been attained (e.g., once a quorum of those members attending in person or by proxy has been obtained at a regular/annual or special meeting of the members of the Association, a majority of those members attending the meeting in person or by proxy may amend these Articles). However, if the required quorum is not achieved at the first such meeting of the members duly called for the purpose of amending the Articles, another meeting of the members may be called on due notice to the members of the Association to be held no sooner than thirty (30) days following the first meeting at which the required quorum was not achieved. The quorum for such second meeting of the members shall be one-half (1/2) of the quorum for the first meeting of the members.

SECOND: The date of adoption of the Amendment was the 17 day of March, 2005

THIRD: Adoption of Amendment:

Article XIII of the Articles of Incorporation, in effect prior to the adoption of the instant Amendment, provides that amendments to the Articles of Incorporation may be approved by the affirmative vote of two-thirds (2/3) of the members of the Association.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted this Amendment in accordance with the above-stated provision. **The number of votes cast for the Amendment was sufficient for approval.**

THE ASSOCIATION has caused these presents to be executed in its name, this 19 day of March, 20 15.
