# AMENDMENT TO THE ARTICLES OF INCORPORATION OF LOGGERS' RUN, INC.

The original Declaration of Protective Covenants and Restrictions for Loggers' Run is recorded in Official Records Book 2793, Page 1, of the Public Records of Palm Beach County, Florida.

The original Articles of Incorporation of Loggers' Run, Inc. are recorded in Official Records Book 2793, Page 34 of the Public Records of Palm Beach County, Florida.

As indicated herein, words <u>underlined</u> are added and words <del>struck through</del> are deleted.

A new Article XVI shall be added to the Articles of Incorporation of Loggers' Run, Inc. as follows:

BULK RATE CABLE TV. Notwithstanding anything to the contrary contained in the Loggers' Run documents, including the Association Articles of Incorporation or By-Laws, the Board of Governors has the authority to enter into a contract for bulk rate cable television. The cost of this service shall be an operating expense which shall be assessed and collected in the same manner as assessments are otherwise levied and collected pursuant to the Declaration, Articles of Incorporation and By-Laws. However, the contract must provide that any hearing impaired or legally blind owner or tenant who does not occupy the residence with a non-hearing impaired or sighted person may not be required to have the service and neither the owners nor the Association shall be required to pay any charge related to such service.
