EXHIBIT "A"

AMENDMENT TO THE ARTICLES OF INCORPORATION OF LOGGERS' RUN, INC.

The original Declaration of Protective Covenants and Restrictions for Loggers' Run is recorded in Official Records 2793, Page 1, of the Public Records of Palm Beach County, Florida.

The original Articles of Incorporation of Loggers' Run, Inc. are recorded in Official Records Book 2793, Page 34 of the Public Records of Palm Beach County, Florida.

As indicated herein, words <u>underlined</u> are added and words struck through are deleted.

Item 1: Article X, Section C of the Articles of Incorporation of Loggers' Run, Inc. shall be amended as follows:

C. Commencing at the 2006 Annual Meeting and Election of Directors, F the Board of Governors shall be composed of fifteen (15) sixteen (16) Governors: as follows: The Board of Governors shall be composed of two (2) Board Members designated by each Association Member and one (1) Board Member designated by Crystal Cove Estates Homeowners Association, Inc. The Association Members (Timberwalk Association, Inc., Timberwalk II Association, Inc., Winding Lakes Section III Homeowners Association, Inc. (now known as Winding Lake Estates), and Island Lakes Section I Homeowners Association, Inc.) and Crystal Cove Estates Homeowners Association, Inc., shall designate their Governors by a majority vote of their respective Boards of Directors. The remaining six (6) seven (7) Governors shall be elected by the Members of the Corporation at the Annual Meeting of the Corporation as set forth in the Bylaws of the Corporation ("At Large Governors"). Members of the Corporation who are also Members of an Association Member or of Crystal Cove Estates Homeowners Association, Inc., shall not be eligible to serve as one of the seven (7) At Large Governors, but shall only be eligible to serve as a Governor appointed by their respective Association Member or by Crystal Cove Estates Homeowners Association, Inc., as provided herein. Notwithstanding the foregoing, if there are fewer than seven (7) At Large Governors elected at any Annual Meeting, then the number of At Large Governors will be reduced to equal the number of At Large Governors elected for that year only. If the number of At Large Governors is reduced as provided above, and there is a further resignation, then the vacancy caused by that resignation shall be filled by the affirmative vote of the majority of the remaining Governors. The vacancy for an At Large Governor position must be filled by a member of an At Large community (i.e., not an Association Member or a Member of Crystal Cove Estates Homeowners Association, Inc.).
