AMENDMENTS TO ARTICLES OF INCORPORATION

FOR

ST. GEORGE PLANTATION OWNERS' ASSOCIATION, INC.

<u>ARTICLE III</u>

Every person or entity who is a record owner of a fee or undivided fee interest in any lot which is subject by covenants of record to assessment by the Association, including contract sellers, but excluding persons or entities holding title merely as security for performance of an obligation, shall be a member of the Association. Membership shall be appurtenant to and may not be separated from ownership of a lot which is subject to assessment by the Association. Every person or entity who is a record owner of a fee or undivided fee interest in any parcel which is subjected by the 2004 Resort Village Agreement dated March , 2004 to assessment by the Association, excluding persons or entities holding title merely as security for performance of an obligation, shall be a special member of the Association. Membership shall be appurtenant to and may not be separated from ownership of a parcel which is subject to assessment by the Association.

ARTICLE VII
