ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

The undersigned, being the President of RUNAWAY BAY CONDOMINIUM ASSOCIATION, INC., a Florida not-for-profit corporation, hereby certifies that the following Amendment to the Articles of Incorporation was validly and duly adopted and approved by an affirmative vote of the members owning not less than seventy-five (75) percent of the corporation, as is required by Article XV of the Articles of Incorporation. The number of votes cast was sufficient to amend the Articles of Incorporation. This amendment was adopted by the members on the 23 day of 1997.

<u>AMENDMENT</u>

(Strike throughs are deletions; underlined words are additions or changes)

Article XV is amended as follows:

An Amendment or Amendments to these Articles of Incorporation may be proposed by the Board of Directors of the Corporation acting upon a vote of the majority of the Directors, or by the members of the Corporation owning a majority of the Condominium Units in the Condominium, whether meeting as members or by instrument, in writing, signed by them. Upon any amendment or amendments to these Articles of Incorporation being proposed by said Board of Directors or members, such proposed amendment or amendments shall be transmitted to the President of the Corporation or other Officer of the Corporation, in the absence of the President, who shall, thereupon, call a Special Meeting of the Members of the Corporation for a date not sooner than fifteen (15) days, or later than forty-five (45) days from the receipt by him of the proposed amendment or amendments, and it shall be the duty of the Secretary to give each member written or printed notice of such meeting, stating the time and place of the meeting and reciting the proposed amendment or amendments in

If mailed, such notice shall be deemed to be properly given when deposited in the United States mail, addressed to the member at his post office address as it appears on the records of the Corporation, the postage thereon prepaid. Any member may, be written waiver of notice signed by such member, waive such notice, and such waiver, when filled in the records of the Corporation, whether before or after the holding of the meeting shall be deemed equivalent to the giving of such notice to such member. At such meeting, the amendment or amendments proposed may be approved by an affirmative vote of the members owning not less than seventy-five percent (75%) fifty-one percent (51%) of the Corporation in order for such amendment or amendments to become effective. Thereupon, such amendment or amendments of these Articles of Incorporation shall be transcribed and certified in such form as may be necessary to register the same in the office of the Secretary of State, State of Florida, and upon the registration of such amendment or amendments with said Secretary of State a certified copy thereof shall be recorded in the Public Records of Broward County Manatee County, Florida, within then (10) days from the date on which the same are so registered. At any meeting held to consider such amendments of these Articles of Incorporation, the written vote of any member of the Corporation shall be recognized, if such member is not in attendance at such meeting or represented thereat by proxy, provided such written vote is delivered tof he Secretary of the Corporation at or prior to such meeting.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
