

ARTICLES OF AMENDMENT TO CERTIFICATE OF REINCORPORATION OF

MANATEE COUNTY BOYS DEVELOPMENT ASSOCIATION, IN

ARTICLE I

The name of the Corporation is Manatee County Boys Development Association Inc. (the Corporation").

ARTICLE II

Article III of the Certificate of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following new Article III
