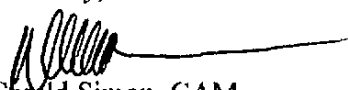
The above named Condominium Association was dissolved during the 1997 fiscal year. The reason for the dissolution is that the old registered agent did not forward the forms to the management company.
