**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
NEW TRIBES MISSION, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

- 1. The current name of the corporation is New Tribes Mission, Inc. (the "Corporation").
- 2. The date of filing of the original Articles of Incorporation of the Corporation was June 20, 1978, document number 743327.
- 3. The Articles of Incorporation of the Corporation are amended by deleting Article I in its entirety and inserting the following section in its place and stead:


"Article I
