ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR RAINBERRY BAY MASTER ASSOCIATION, INC.

EXHIBIT "A"

AMENDMENTS TO THE ARTICLES OF INCORPORATION OF RAINBERRY BAY MASTER ASSOCIATION, INC.

The Homeowners Association Covenants for Rainberry Bay are recorded in Official Records Book 2882, at Page 1318, in the Public Records of Palm Beach County, Florida.

As indicated herein, words <u>underlined</u> are added and words struck through are deleted.

Item 1: Article III, Section 3, of the Articles of Incorporation of Rainberry Bay Master Association, Inc., entitled Meeting of Members, shall be amended as follows:

The By-Laws of the Association shall provide for an annual meeting of members, and may make provision for regular and special meetings of members other than the annual meeting. A quorum for the transaction of business at any meeting of the members shall exist if 33 1/3% of the total number of members in good standing shall be present or represented at the meeting by proxy or by absentee ballot.

Item 2. Article VIII of the Articles of Incorporation shall be amended as follows:

Amendments to these Articles of Incorporation shall be proposed and approved by the Board of Directors and thereafter submitted to a meeting of the membership of the Association for adoption by a majority of the members present and voting in person or by proxy or by absentee ballot.
