ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATIONS

1. Original Organizers: First Christian Church Of The Living God, Inc. Reverend Richard W. Mims, the late Deacon Claude Mc Neill and Sister Flora J. Mims.
2. (A) Name: NewLife Christian Fellowship Church Center, Inc.  
(B) Purpose: 1. To recruit souls for Jesus Christ. 2. To help clothe and feed needy families. 3. To offer free counseling and other family services. 4. Community ministries.  
(C) Admission: All members will be governed by the rules and regulations of the Holy Bible (King James Version).  
(D) Term of Existence: Continual  
(E) Subscribers: Rev. Richard W. Mims, 7615 Palmbrook Drive, Tampa, Fl, Flora J. Mims, 7615 Palmbrook Drive, Tampa, Fl, Vivian B. Mathews, 6406 Axelrod Road, Tampa, Fl and Leola Anne Ellison, 8700 N. 50th Street #1336, Tampa, Fl.  
(F) Officers: Pastor, Deacons and Trustees. New electees will be appointed by the Pastor as the church grows. Pastors and deacons will retain their duties until they retire, resign or as stated in Articles IV(A), IV(D) and XVI (A & B). Trustees shall be appointed by the Pastor and approved by 2/3rd vote of the tithe paying congregation, to serve for a time not less than three (3) years and not more than five (5) years. Trustees service time may be renewed by the Pastor or as stated in Article IV(D).  
(G) Present Officers: Rev. Richard W. Mims, Pastor, Trustees: Arleaser Aldridge, Debra Brown, Vivian B. Mathews; Financial Secretary, Flora J. Mims; Recording Secretary, Leola Anne Ellison.  
(H) Board of Directors: Rev. Richard W. Mims, Director; Vivian B. Mathews, Director; Nathaniel F. Mathews, Director; Flora J. Mims, Financial Secretary Director; Leola Anne Ellison, Recording Secretary Director.  
(I) By-Laws may be made, altered or rescinded by Pastor, Trustees and 2/3rd vote of the tithe paying congregation. After the departure of Rev. Richard W. Mims (an organizer) the by-laws shall be made, altered or rescinded by Trustees and 2/3rd vote of the tithe paying congregation.
