**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
AGENCY FOR COMMUNITY TREATMENT SERVICES, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, Agency For Community Treatment Services, Inc., a Florida corporation not-for-profit, (*“the or this corporation”*) adopts the following amendments to its Articles of Incorporation:

1. Name of Corporation. The name of the corporation is Agency For Community Treatment Services, Inc. Its original Articles of Incorporation were filed and recorded with the Florida Department of State on November 2, 1978, document number 744798.

2. Amendment. The Articles of Incorporation of the corporation, as previously amended are hereby further amended as follows:

Article II of the Articles of Incorporation of the corporation is amended and restated in its entirety by the following provisions, which replace and supersede such Article II as it previously existed:

**ARTICLE II
Nature of Business**


This corporation is organized for the following purposes:

- (a) To increase public interest in substance abuse, co-occurring substance abuse and mental illness, and all forms of behavioral disorders and their effects.
- (b) To provide and manage a comprehensive range of prevention, intervention, treatment, and supportive services related to substance abuse and mental illness; and to provide services to those in need involving child protection, delinquency, criminal justice, housing, economic self-sufficiency, and health and wellness.
- (c) To buy, sell, acquire, construct, lease, operate, and maintain (i) housing facilities for the homeless, mentally disabled, otherwise disadvantaged, and those in need, (ii) offices, (iii) libraries, (iv) other facilities, and (v) other assets, all for the use and benefit of the corporation and those whom the corporation is dedicated to serve.
- (d) To establish and maintain affiliate agreements between the corporation and other providers whose services may be necessary to maintain the corporation and to fulfill its purposes.
- (e) To engage in any and all lawful business, trades, occupations, or professions not incompatible with those listed above.

3. Date of Adoption and Sufficient Approval. The above amendment was adopted on February 11, 2015 by the unanimous written consent of, and signed by, all of the members of the Board of Directors of the corporation who also constitute all of the members of the corporation. Such adoption and approval is authorized by Section 617.0701(4) and Section 617.0821 of the Florida Statutes and is sufficient to adopt such amendment; and such written consent has been filed with the minutes of the corporation.
