

ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

GAY AND LESBIAN COMMUNITY SERVICES OF CENTRAL FLORIDA, INC.

Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, originally filed on November 27, 1978 as Document Number 745066.

FIRST: The name of this corporation is GAY AND LESBIAN COMMUNITY SERVICES OF CENTRAL FLORIDA, INC.

SECOND: The following amendment to the Articles of Incorporation was adopted by the corporation: Article 1 of the Articles of Incorporation is repealed and replaced by the following:

ARTICLE 1

The name of this corporation is GAY, LESBIAN & BISEXUAL COMMUNITY CENTER OF CENTRAL FLORIDA, INC.

THIRD: The board of directors of the corporation adopted the above amendment to the Articles of Incorporation on August 23, 1998.

FOURTH: The members of the corporation adopted the above amendment to the Articles of Incorporation on August 23, 1998 and the number of votes cast for the amendment was sufficient for approval.
