

ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF WOODSIDE VILLAGE CONDOMINIUM ASSOCIATION, INC.

Adopted amendment to ARTICLE X, Section 10.2 of the Articles of Incorporation of Woodside Village Condominium Association, Inc., to read as follows:

ARTICLE X

AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner.

10.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by sixty-six and two thirds percent (66 2/3%) of the members of the Association. Directors and members not present in person or by proxy at the meeting to consider the amendment may express their approval in writing, provided such approval is delivered to the Secretary prior to such meeting. A resolution adopting a proposed amendment must be approved by the affirmative vote of sixty-six and two-thirds percent (66 2/3%) a majority of the members of the Association present in person or by proxy at a meeting at which a quorum is present.
