(e) insofar as permitted by law, to do any other thing that, in the opinion of the Board of Directors, will promote the common benefit and enjoyment of the residents of The Properties including, without limitation. entering into bulk rate cable television service and/or master antenna television service contracts or agreements for the Lots and Living Units, the cost of which shall be levied as part of the Periodic Assessments under the Declaration and, through the Board of Directors, granting such easements and licenses with respect to the Properties as the Board may deem reasonably necessary in connection with any bulk rate cable television or master antenna television service contract or agreement entered into by the Board of Directors on behalf of the Association providing such service(s) to the Lots and Living Units as a common expense; and ...
