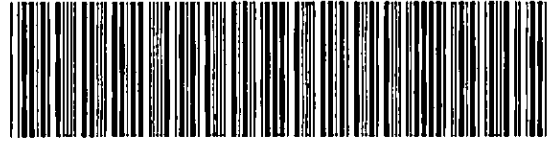


Pursuant to the provisions of Sections 617.1006, Florida Statutes, this Florida not for profit corporation (the "**Corporation**"), hereby adopts the following amendment to its Amended and Restated Articles of Incorporation dated October 3, 2021, as follows:

**Amendment #1 - Name Change.** The name of the Corporation shall be changed to:

**IVY ENRICHMENT FOUNDATION OF TAMPA BAY, INCORPORATED**
