ARTICLES OF INCORPORATION

OF

FAIRGREEN UNIT VI OWNERS ASSOCIATION, INC.

A Corporation not for profit under the laws of the
State of Florida

In order to form a corporation under and in accordance with
the provisions of the laws of the State of Florida for the
formation of corporations not for profit, we, the undersigned,
hereby associate ourselves into a corporation for the purpose, and
with the powers hereinafter mentioned; and to that end we do, by
these Articles of incorporation, set forth:

ARTICLE I

NAME

The name of the corporation shall be FAIRGREEN UNIT VI
OWNERS ASSOCIATION, INC. For convenience, the corporation shall
be referred to in this instrument as the "Association".

ARTICLE II

PURPOSE

2.1 The purpose for which the Association is organized is to
provide an entity to carry out and accomplish the purposes des-
cribed in the Declaration of Covenants and Restrictions for
Sunreco, Inc., FAIRGREEN Unit VI, as recorded in the Public
Records of Volusia County, Florida, and, to undertake such manage-
ment, maintenance, operation, ownership and other duties with
respect to the subdivision described in the above Declaration and
to any other land or property which may be submitted to said
Declaration in accordance therewith.

2.2 The Association shall make no distributions of income to
its members, directors or officers, being conducted as a nonprofit
organization for the benefit of its members.

ARTICLE III

POWERS

The Association shall have the following powers:

3.1. The Association shall have all of the common law and statutory powers of a corporation not for profit not in conflict with the terms of these Articles.

3.2. The Association shall have the power to administer and enforce the provisions of the Declaration more fully described in Article II hereof and all of the powers and duties reasonably necessary to carry out the responsibilities and duties conferred upon it by the Declaration, as it may be amended and supplemented from time to time, including but not limited to the following:

- a. To make and establish reasonable rules and regulations regarding the use of the Association common property subject to its jurisdiction.
- b. To make and collect assessments against members of the Association to defray the cost, expenses and losses of the Association.
- c. To use the proceeds of assessments in the exercise of its powers and duties.
- d. To maintain, repair, replace, operate and manage the Association property, including the right to reconstruct improvements after casualty and to make and construct additional improvements upon the Association property.
- e. To purchase insurance upon the Association property and improvements and insurance for the protection of the Association and its members.
- f. To enforce by legal means the provisions of the Declaration of Covenants and Restrictions, as amended from time to time, these Articles of Incorporation, the By-Laws of the Association which may be hereafter adopted and the rules and regulations governing the use of the Association property.
- g. To contract for the management of the Association property and to delegate to such contractor all powers and duties of the Association except such as are specifically required by

the Declaration of Covenants and Restrictions to have approval of the Board of Directors or the membership of the Association.

h. To contract for the management and operation of portions of the Association property susceptible to separate management or operation.

i. To employ personnel and engage such professional assistance as may be necessary to perform the services required for the proper operation of the Association and its properties.

j. To exercise, undertake and accomplish all of the rights, duties and obligations which may be granted to or imposed upon the Association pursuant to the Declaration of Covenants and any Declaration supplementary thereto.

k. To organize, promote and support undertakings and activities for the benefit and general welfare of the residents of FAIRGREEN Unit VI Subdivision.

3.3 All funds and the titles of all properties acquired by the Association, and their proceeds, shall be held for the benefit of the members of the Association in accordance with the provisions of the Declaration of Covenants and Restrictions, these Articles of Incorporation and the By-Laws.

3.4 In the event of the dissolution of the Association, title to all real property shall vest in the abutting lot owners as at common law, subject, however, to the same easements and rights of users by the Residents of FAIRGREEN Unit VI as existed prior to dissolution. Upon dissolution of the Association, all money and other personal property of the Association shall be owned in

ONE HUNDRED TWENTY-TWO equal shares, being one (1) share for the owners of each lot in the Subdivision.

ARTICLE IV

MEMBERS

The qualifications of the members, the manner of their admission to membership and termination of such membership, and

voting by members shall be as follows:

4.1. The membership of the Association shall consist of every person who is the record owner of a fee estate or life estate in any lot in FAIRGREEN Unit VI, so long as such ownership interest shall exist.

4.2. Immediately upon the divestment of a members' ownership interest in a lot, regardless of the means by which such ownership may be divested, such owners' membership shall terminate. Any successor owner shall be entitled to membership after providing written notice to the Association of such ownership interest. At the request of the Association, the successor shall provide the Association with a certified copy of the instrument evidencing his ownership interest.

4.3. The interest of a member in the funds and assets of the Association cannot be assigned, hypothecated or transferred in any manner except as an appurtenance to his unit. The funds and assets of the Association belong solely to the Association subject to the limitation that the same be expended, held or used for the benefit of the membership and for the purposes authorized herein, in the Declaration of Covenants and Restrictions, and in the By-Laws which may be hereafter adopted.

4.4. On all matters on which the membership shall be entitled to vote, there shall be one vote appurtenant to each lot in FAIRGREEN Unit VI Subdivision. Votes may be exercised or cast by the owner or owners of each lot as may be provided in the Declaration of Covenants and Restrictions and the By-Laws hereafter adopted by the Association.

ARTICLE V

PRINCIPAL OFFICE AND DESIGNATION OF RESIDENT AGENT

The principal office of the Association shall be located at 16 Chip Lane, New Smyrna Beach, Florida, but the Association may maintain offices and transact business in such other places within or without the State of Florida as may from time to time be designated by the Board of Directors. The Board of Directors

shall also have the right to relocate the principal office. The initial resident agent of the Association shall be Gerald T. Schweikart, whose address is 16 Chip Lane, New Smyrna Beach, Florida. The Board of Directors may, from time to time, change the resident agent by designation filed in the office of the Secretary of State.

ARTICLE VI

DIRECTORS

6.1 The affairs of the Association will be managed by a Board consisting of not less than three (3) nor more than nine (9) directors. The number of members of the Board of Directors shall be as provided from time to time by the By-Laws of the corporation, and in the absence of such determination, shall consist of three (3) directors. Directors need not be members of the Association.

6.2 Directors of the Association shall be elected at the annual meeting of the members in the manner determined by the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws.

6.3 The election of the Directors shall be held on the second Friday in November 1981, and annually thereafter. The directors named in these Articles shall serve until successor directors are elected and any vacancies in their number occurring before such election shall be filled by the remaining directors.

6.4 The names and addresses of the members of the first Board of Directors who shall hold office until their successors are elected and have qualified, or until removed, are as follows:

6.5. The Board of Directors shall elect a President, Vice-President, Secretary-Treasurer, and as many Assistant Secretaries as the Board of Directors shall determine. The President shall be elected from among the membership of the Board of Directors, but no other officers need be a director. The same person may hold two offices, the duties of which are not incompatible; provided, however, that the office of President and Vice-President shall not be held by the same person, nor shall the President be also the Secretary-Treasurer or an Assistant Secretary.

ARTICLE VII

OFFICERS

The affairs of the Association shall be administered by the officers elected by the Board of Directors. The officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board of Directors. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

ARTICLE VIII

INDEMNIFICATION

Every director and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding or any settlement of any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer of the Association, whether or not he is a director or officer at the time

such expenses are incurred, except when the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties; provided that in the event of a settlement, the indemnification shall apply only when the Board of Directors approved such settlement and reimbursement as being for the best interest of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.

ARTICLE IX

BY-LAWS

The first By-Laws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the By-Laws.

ARTICLE X

TERM

The term of the Association shall be perpetual.

ARTICLE XI

AMENDMENTS

Except as otherwise herein provided, amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

11.1 A resolution for the adoption of a proposed amendment may be proposed by the Board of Directors of the Association acting upon a vote of a majority of the directors, or by members of the Association to whose lots 25% of the total votes are appurtenant, whether meeting as members or by instrument in writing signed by them.

11.2 Upon any amendment or amendments to these Articles of Incorporation being proposed by said Board of Directors or members, such proposed amendment or amendments shall be transmitted to the President of the Association or other officer of the Association in the absence of the President, who shall thereupon call a special meeting of the members of the Association for a day no sooner than

than (10) days nor later than thirty (30) days from the receipt by him of the proposed amendment or amendments, and it shall be the duty of the Secretary to give each member written or printed notice of such meeting, stating the time and place of the meeting and reciting the proposed amendment or amendments in reasonably detailed form. Such notice shall be mailed to or presented personally to each member not less than ten (10) nor more than thirty (30) days before the date set for such meeting. If mailed, such notice shall be deemed to be properly given when deposited in the United States mail, addressed to the member at his post office address as it appears on the records of the Association, the postage thereon prepaid. Any member may, by written waiver of notice signed by such member, waive such notice, and such waiver when filed in the records of the Association, whether before or after the holding of the meeting, shall be deemed equivalent to the giving of such notice to such member. In order to become effective, the proposed amendment or amendments must be approved by the affirmative vote of a majority of the total votes appurtenant to all lots subject to Association assessment.

A copy of each amendment, after it has become effective, shall be transcribed and certified in such form as may be necessary to register the same in the office of the Secretary of State of the State of Florida, and upon the registration of such amendment or amendments with the Secretary of State, a certified copy thereof shall be recorded in the Public Records of Volusia County, Florida.

11.3 At any meeting held to consider any amendment or amendments of these Articles of Incorporation, the written vote of any member of the Association shall be recognized, if such member is not in attendance at such meeting or represented thereat by proxy, provided such written vote is delivered to the Secretary of the Association at or prior to such meeting.

11.4 No amendment of these Articles shall be made that is in conflict with the Declaration of Covenants and restrictions as amended from time to time. No amendment to these Articles of Incorporation which

shall abridge, amend or alter the rights of Sunreco, Inc. or a successor developer may be adopted or become effective without the prior written consent of Sunreco, Inc. or such successor.

A plaintiff need not wait for the exception stated in Section 119 (7)(b)(v), Florida Statutes, to file a motion for a preliminary injunction. The trial court may grant a preliminary injunction at any time prior to trial if it finds that the defendant has violated or is about to violate the law.
