Moore, as Vice-President and Bernadette Cremmins as Secretary of East Lake Woodlands Cypress Estates Condominium Unit Two Association, Inc., do hereby certify that by the affirmative vote of not less than 80% of the entire membership at the Special Membership Meeting of the members held September 8, 1998 held in accordance with the By-Laws of this Association, the following amendment to the Articles of Incorporation was duly enacted:

ARTICLE 9.2 OF THE ARTICLES OF INCORPORATION IS AMENDED TO READ AS FOLLOWS:

- 9.2 Adoption. A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approval must be either: by not less than 51% of the votes of the entire membership of the Association.
- (a) By not less than 75% of the entire membership of the board of directors and by not less than 75% of the votes of the entire membership of the Association; or
- (b) By not less than 80% of the votes of the entire membership of the Association.
