#### **AMENDMENT TO ARTICLE XIII.3 OF THE ARTICLES OF INCORPORATION OF** POINCIANA PLACE CONDOMINIUM ASSOCIATION VI. INC.

XIII

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

3. VOTE NECESSARY; FILING. In order for such amendment or amendments to become effective, the same must be approved by an affirmative vote of sixty-six (66%) percent a majority of the entire membership of the Board and by an affirmative vote of the members having seventy-five percent (75%) fifty-one percent (51%) or more of the votes in the Association. Such amendment or amendments shall be filed within ten (10) days from said approval with the Office of the Secretary of State of Florida for approval, along with the appropriate filing fee.

Notwithstanding the foregoing provisions of this Article XIII, no amendment to these Articles of Incorporation may be adopted or become effective without the prior written consent of Sponsor, and Challenger Club if such amendment affects the rights of such entity or affects, in Sponsor's sole opinion which shall be binding, the Sponsor's ability to sell Units in this or other condominiums located at Poinciana Place.
