# Pursuant to Section 617.1006 of the Florida Business Corporation Act

ST. PETERSBURG NEIGHBORHOOD HOUSING SERVICES, INC., a Not For Profit corporation organized and existing under any by virtue of the Florida Not For Profit Corporation Act (hereinafter called the "Corporation") DOES HEREBY CERTIFY that:

FIRST: Article Five of the Articles of Incorporation of the Corporation be, and it hereby is, amended to read as follows:

#### Article Five

## <u>Officers</u>

The affairs of the Corporation are to be managed by the President, Vice-President, Secretary, Treasurer and such assistant or additional officers as are provided for in the By-Laws.
