

APPROVED AMENDMENTS TO THE ARTICLES OF INCORPORATION OF BELLEVIEW BILTMORE VILLAS-SOUTH GARDEN-8 BELLEVIEW BLVD., INC.

1. Amend Article III, Section 3.2(f), of the Articles of Incorporation to read as follows:

III. Power

The powers of the Association shall include and be governed by the following provisions:

3.2 The Association shall have all of the powers and duties set forth in the Condominium Act except as limited by these Articles and the Declaration of Condominium, and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration as may be amended from time to time, including but not limited to the following:

f. To make and amend reasonable rules and regulations respecting the use of the property in the condominium other than the restrictions contained in the Declaration of Condominium; provided, however, that all such regulations and their amendments shall be approved by not less than seventy five percent of the votes of the entire membership of the Association before such shall become effective.

2. Amend Article IX, Section 9.2(a) and (b), of the Articles of Incorporation to read as follows:

IX. Amendments

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner.

9.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided:

- a. Such approvals must be by not less than seventy-five percent of the entire membership of the Board of Directors and by not less than seventy-five percent of the votes of the entire membership of the Association those voting members present and voting in person or by proxy at the duly noticed meeting of the membership at which a quorum has been attained; or
- b. By not less than eighty percent of the votes of the entire membership of the Association those voting members present and voting in person or by proxy at the duly noticed meeting of the membership at which a quorum has been attained.
