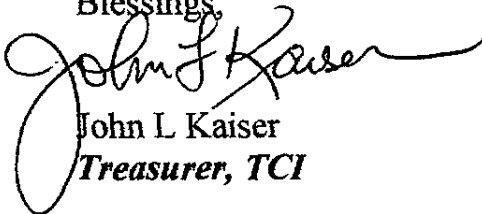
Dear Teresa,

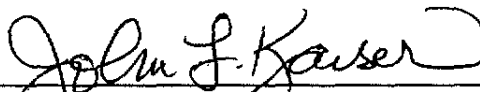
