



TO ARTICLES OF INCORPORATION

Palm Beach Radio Control Association, Inc. -

WINDY-2 MM \$ 26 Pursuant to the provisions of section 617.1006, Florida Statutes, The undersigned Florida fi corporation adopts the following articles of amendment to its articles of incorporation.

AMENDED ADOPTED ARTICLE XVI ADDED

ADDITIONAL PROVISIONS

Said organization is organized exclusively for Pleasure, recreation & social activities, including, for such purposed, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(7) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(7) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(7) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the country in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

On motion and by unanimous vote by the board of directors, the preceding articles of amendment of Palm Beach Radio Control Association, Inc. were adopted. There are no members or members entitled to vote on the amendments.
