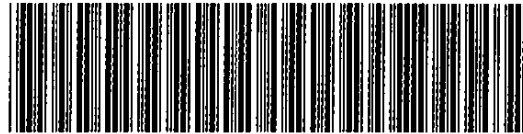

PLAN OF PHASE DEVELOPMENT AND PURPOSE
OF ASSOCIATION

A. Statement of the Plan of Phase Development

3. Developer is also the owner of certain real property upon which Developer intends to construct certain recreational facilities and other improvements for the use by all Apartment Owners.
