## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF 97 AUG 28 AM II: 17 THE WEST ORANGE HEALTH CARE FOUNDATION, SINC.

Pursuant to the provisions of Section 617.1002, Florida Statutes, the WEST ORANGE HEALTH CARE FOUNDATION, INC., a Florida not-for-profit corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is the WEST ORANGE HEALTH CARE FOUNDATION, INC.
- The original Articles of Incorporation for the Corporation were filed on February
   1981, and assigned Document No. 756562.
  - 3. The Articles of Incorporation are hereby amended to read as follows:

<u>FIRST</u>, all references in the Articles to the "West Orange Memorial Hospital Tax District" are hereby changed to the "West Orange Health Care District" to reflect the District's current name.

SECOND, Article V is hereby amended to read in its entirety as follows:

## ARTICLE V MEMBERSHIP

The membership of this Foundation shall consist of one (1) member, which shall be the West Orange Health Care District.

THIRD, Article VI is hereby amended to read in its entirety as follows:

## ARTICLE VI BYLAWS

The Bylaws of the Foundation shall be adopted and amended as necessary by a vote of a majority of the Directors of the Foundation, subject at all times to the approval of the sole member.

FOURTH, Article IX is hereby amended to read in its entirety as follows:

## ARTICLE IX AMENDMENTS

Any amendment to the Articles of Incorporation shall require a twothirds (2/3rds) vote of the Directors of the Foundation, and shall further be subject to the approval of the sole member.

4. Article IX of the Articles of Incorporation provides that the Articles may be amended by a two-thirds (2/3rds) vote of the Directors. Members are not required to approve such amendments. In accordance with such provision, the foregoing Articles of Amendment to the Articles of Incorporation of the Corporation were adopted by the Board of Directors at a regular meeting held on May 20, 1997 by a vote of more than two-thirds (2/3rds) of all the Directors.
