ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF WEST ORANGE HEALTH CARE FOUNDATION, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida not-for-profit corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is West Orange Health Care Foundation, Inc. (the "Corporation").
- 2. Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

ARTICLE I

NAME

The name of this corporation shall be Health Central Foundation, Inc.

3. Article IX of the Articles of Incorporation provides that the Articles of Incorporation may be amended by a two-thirds (2/3rds) vote of the Directors, subject to the approval of the sole member of the Corporation. In accordance with such provisions, the foregoing amendment to the Articles of Incorporation of the Corporation was adopted by the Board of Directors of the Corporation at a regular meeting held on January 20, 1998 by a vote of more than two-thirds (2/3rds) of all of the Directors, by the sole member of the Corporation on January 20, 1998, and the number of votes cast for the amendment was sufficient for approval.

4. The effective date of the foregoing amendment to the Articles of Incorporation of the Corporation shall be as of the date of filing of these Articles of Amendment to the Articles of Incorporation with the Secretary of State of the State of Florida.

IN WITNESS WHEREOF, the undersigned President of the Corporation has executed these Articles this 20th day of January, 1998, on behalf of the Corporation.
