**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
CENTER GATE VILLAGE CONDOMINIUM ASSOCIATION SECTION SIX, INC.**

The undersigned officer of Center Gate Village Condominium Association Section Six, Inc., a not for profit corporation organized and existing under the laws of the State of Florida, hereby certifies that the following amendment to the Articles of Incorporation was approved by not less than seventy-five percent (75%) of the voting interests of the entire membership of the Association at a membership held on March 16, 2002, and by not less than seventy-five percent (75%) of the entire membership of the Board of Directors of the Association on the same date. The number of votes cast in favor of the adoption of the amendment was sufficient for approval under the terms of the Articles of Incorporation of the Association, and applicable law.

**ARTICLE III.
POWERS.**

The powers of the Association shall include and be governed by the following provisions:

(B) (6) To make and amend reasonable regulations respecting the use of the property in the condominium; provided however that all such regulations and their amendment shall be approved by not less than a majority vote of the members of the Association at a membership meeting at which a quorum is present, ~~sixty (60%) of the votes of the units of a particular condominium before such shall become effective.~~
