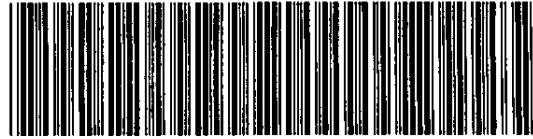


FIRST: The Amendments adopted are attached as Exhibit "A".

The Declaration of Condominium of Beach Walk East Condominium is recorded in Official Record Book 3597, at Page 941, in the Public Records of Palm Beach County, Florida. The Amended and Restated Declaration of Condominium of Beach Walk East Condominium is recorded in Official Record Book 13199, at Page 333, in the Public Records of Palm Beach County, Florida.

As indicated herein, words underlined are added and words ~~struck through~~ are deleted.

**Item 1: Article X, Section 1(b) of the Articles of Incorporation for Beach Walk East Condominium Association, Inc. ("Articles of Incorporation") shall be amended as follows:**

(b) These Articles of Incorporation may be amended at any regular or special meeting of the unit owners of this Condominium called or convened in accordance with the Bylaws or by written agreement in lieu of a meeting in accordance with the procedure set forth in the Bylaws, by the affirmative vote of 75% of those owners voting, in person or by proxy, at a duly called meeting of the membership, at which a quorum has been obtained, so long as at least a majority of the entire membership has approved such amendment. ~~the total votes of the membership of the Association.~~ All amendments shall be recorded and certified, as required by the Condominium Act.
