## AMENDMENT TO THE ARTICLES OF INCORPORATION OF CYPRESS POINT VILLAS ASSOCIATION, INC.

The Declaration of Covenants, Conditions and Restrictions for Cypress Point Villas is recorded in Official Records Book 3737, at Page 151, of the Public Records of Palm Beach County, Florida. The Amended and Restated Declaration of Covenants, Conditions and Restrictions for Cypress Point Villas is recorded in Official Records Book 7659, at Page 1542, of the Public Records of Palm Beach County, Florida. The Articles of Incorporation for Cypress Point Villas Association, Inc. is recorded in Official Records Book 7659, at Page 1565, of the Public Records of Palm Beach County, Florida.
