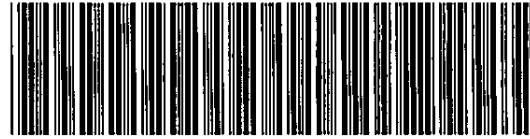

SECOND: There are no members entitled to vote on the Amendments. The Amendment was adopted by the Board of Directors on April 2, 2013.

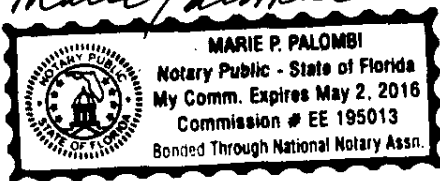

**AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
CYPRESS POINT VILLAS ASSOCIATION, INC.**

The Declaration of Covenants, Conditions and Restrictions for Cypress Point Villas is recorded in Official Records Book 3737, at Page 151, of the Public Records of Palm Beach County, Florida. The Amended and Restated Declaration of Covenants, Conditions and Restrictions for Cypress Point Villas is recorded in Official Records Book 7659, at Page 1542, of the Public Records of Palm Beach County, Florida. The Articles of Incorporation for Cypress Point Villas Association, Inc. is recorded in Official Records Book 7659, at Page 1565, of the Public Records of Palm Beach County, Florida.

As indicated herein, words underlined are added and words ~~struck through~~ are deleted.

Item 1. Article I of the Articles of Incorporation of Cypress Point Villas Association, Inc. ("Articles of Incorporation") shall be amended as follows:

I. NAME

The name of this corporation shall be Cypress Point ~~Villas Association~~ HOA of Boca West, Inc., sometimes herein referred to as the "Association". All further references in these Articles of Incorporation or in any of the Association governing documents, including the Bylaws and Declaration of Covenants, Conditions and Restrictions, to the term Cypress Point Villas Association, Inc., shall be deemed to mean and refer to Cypress Point HOA of Boca West, Inc.
