**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
NATIONAL PUBLIC RECORDS RESEARCH ASSOCIATION, INC.**

The following Amended and Restated Articles of Incorporation were adopted by the membership of National Public Records Research Association, Inc., on the 9th day of October, 1999, which vote of the membership was sufficient to adopt the following:

ARTICLE I

The name of this Corporation is National Public Records Research Association, Inc.

ARTICLE II

The purpose for which this Corporation is organized is to transact business and conduct activities in furtherance of the educational goals and professionalism of the Corporation and its members. The Corporation is authorized to undertake activities consistent with those purposes and to undertake any other lawful activities permitted under and pursuant to Chapter 617, Florida Statutes.

ARTICLE III

The membership of this Corporation shall be those persons, firms and corporations who are engaged in or supportive of the business of providing information from public records and who are qualified and admitted to membership as described in the Bylaws of the Corporation.

The Corporation shall have two (2) classes of members, which shall be known as regular members and associate members. Quorum requirements, voting rights, benefits and obligations of membership for each class of members shall be as specified in the Bylaws of the Corporation.

ARTICLE IV

This Corporation is to exist perpetually.

ARTICLE V

The officers of the corporation shall be President, Vice President, Treasurer, Secretary and such other officers as may be provided in the Bylaws.

ARTICLE VI

The business of this corporation shall be managed by the Board of Directors. The number of directors may be increased or decreased from time to time by the Bylaws, but shall never be less than three.

The Board of Directors shall be elected and hold office in accordance with the Bylaws.

ARTICLE VII

The Board of Directors of this Corporation after notice to the membership regarding the subject of the proposed Bylaws or an amendment thereto may adopt or amend Bylaws for the conduct of the business and the carrying out of the purposes of the Corporation as deemed appropriate and necessary by the Board of Directors from time-

to-time. The Bylaws may be amended, altered or rescinded by a two-thirds (2/3) vote of the Board of Directors.

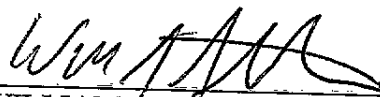
ARTICLE VIII

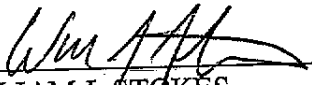
CERTIFICATE

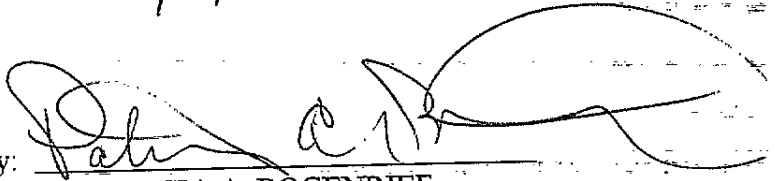
