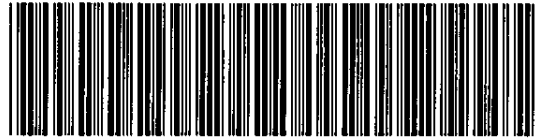

Pursuant to §617.1001, F.S., the undersigned Corporation adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

1. Pursuant to Article I of the Articles of Incorporation of the Corporation the present name of the Corporation is **HOPE OF SOUTHWEST FLORIDA, INC.**
2. Article I is Amended to Read: The name of the Corporation is **HOPE HOSPICE AND COMMUNITY SERVICES, INC.**
