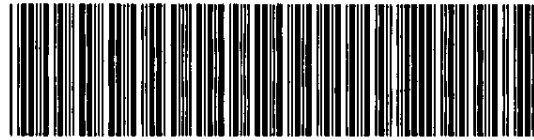

ARTICLE I – NAME

The Corporation shall have the power to buy, acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and improve, encumber, sell, convey and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds of trust, annuity bond, and other instruments of indebtedness to pay interest thereon, to improve, adapt and use property held by it for: **FLORIDA MULTICULTURAL DISTRICT COUNCIL OF THE ASSEMBLIES OF GOD, INC.** or the income there from in the religious, educational, benevolent, or social activities of the **FLORIDA MULTICULTURAL DISTRICT COUNCIL OF THE ASSEMBLIES OF GOD, INC.** or its successor without financial profit to its members except as may be necessary in the payment of salaries, or other compensation for services rendered, and the corporation shall have the power to erect and maintain buildings to be utilize by said corporation, for the worship of God, for the training in Christian faith, and to build maintain residences for the use of ministers of : **FLORIDA MULTICULTURAL DISTRICT COUNCIL OF THE ASSEMBLIES OF GOD, INC.** In conformity with the bylaws of said corporation and all the power and right granted to Corporations Not For Profit under the laws of the State of Florida.

ARTICLE V – MEMBERSHIP

The member s of the corporation shall be all members in good standing at any given time of the: **FLORIDA MULTICULTURAL DISTRICT COUNCIL OF THE ASSEMBLIES OF GOD, INC.** Provided, however, neither the incorporators nor the members of the corporation shall have any vested right, interest, or privilege of, in or to the assets, functions, affairs, or franchises of this corporation, or any right, interest or privilege which may be inheritable, or shall continue after his membership ceases in the
