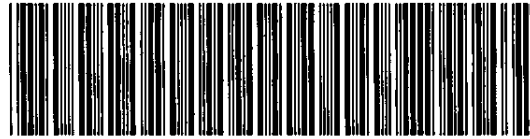



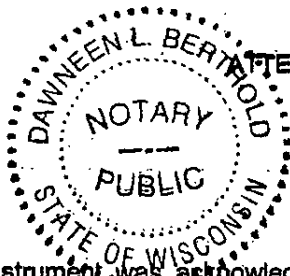

AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
TREASURE CAY CONDOMINIUM ASSOCIATION, INC.**

(Additions indicated by underlining; deletions indicated by ~~striking through~~)

Amendment to Article VIII of the Articles of Incorporation to modify the size of the Board and to implement staggered term elections as follows:

ARTICLE VIII. DIRECTORS

The number of persons constituting the first board of directors is three (3). The names and addresses of the directors who are to serve until the first annual meeting of the members or until their successors are elected and qualified are:

- Ralph E. Cunningham, Jr., 2975 Overseas Highway, Marathon, Florida 33050
- Cynthia F. Hoffmann, 2975 Overseas Highway, Marathon, Florida 33050
- Alfred O. Bragg, 2975 Overseas Highway, Marathon, Florida 33050

~~At the first annual meeting, the members shall elect from among the members of the corporation two (2) directors for a term of One (1) year each, two (2) directors for a term of two (2) years each, and two (2) directors for a term of three (3) years each; at each annual meeting thereafter the members shall elect from among the membership two (2) directors for a term of three (3) years each.~~

The number of persons constituting the Board of Directors following this amendment to the Articles of Incorporation shall be five (5). The manner of election shall be as set forth in the Bylaws of the Association.
