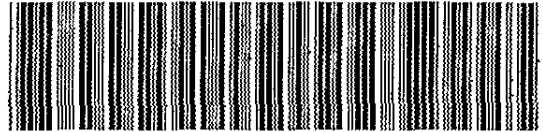





**FIRST:** Articles 1 shall be amended to change the name of the corporation to:


**CHURCH OF HOPE MINISTRIES, INC.**
