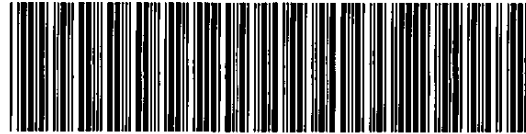

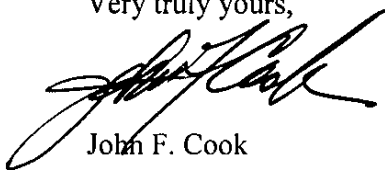

(A Florida Corporation, Not For Profit)

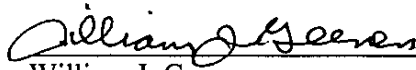

Article I of the Articles of Incorporation is hereby amended to change the name of the Corporation to:

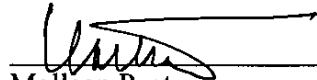
HOLY CROSS ASSOCIATES OF FLORIDA, INC.

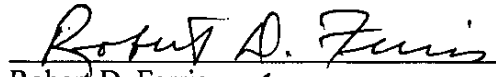

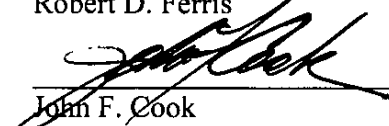
