OF

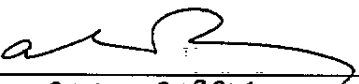
WELLS RIDGE PROPERTY OWNERS ASSOCIATION, INC.

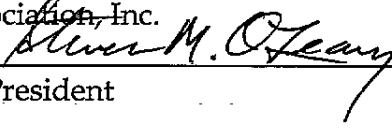

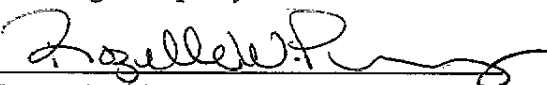
