ARTICLE II-PURPOSES

FIRST FREE WILL BAPTIST CHURCH OF PALM BAY, INC.  
organized exclusively for charitable, religious, educational and  
scientific purposes, including, the making of distributions to  
organizations under Section 501(c)(3) of the Internal Revenue  
Code (or corresponding section of any future Federal tax code).

No part of the net earnings of the  
corporation/organization shall inure to the benefit of, or be  
distributed to its members, trustees, directors, officers or any  
private persons, except that the corporation/organizations shall  
be authorized and empowered to pay reasonable compensation for  
services rendered and to make payments and distributions in  
furtherance of Section 501(c)(3) purposes. No substantial part  
of the activities of the organization shall be the carrying on of  
propaganda, or other wise attempting to influence legislation,  
and the corporation/organization shall not participate in, or  
intervene in, (including the publishing or distribution of  
statements) any political campaign on behalf of, or in opposition  
to, any candidate for public office.

Notwithstanding any other provision of these articles, the
