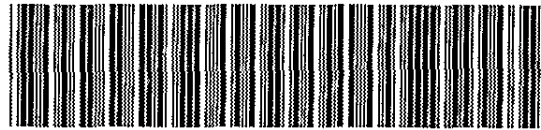

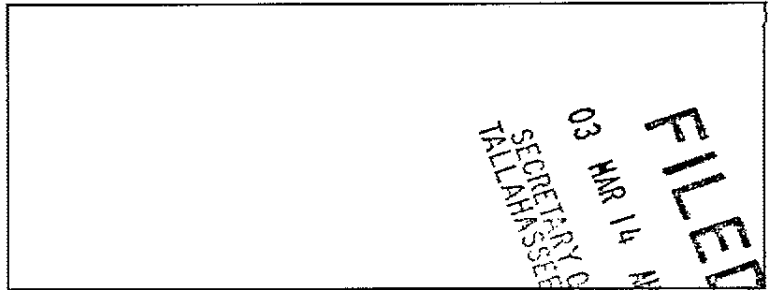

**CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR  
GREEN DOLPHIN PARK MID-RISE CONDOMINIUM ASSOCIATION, INC.**

We, Gerald Clark and Mary LaPlant, as President and Secretary respectively of Green Dolphin Park Mid-Rise Condominium Association, Inc. do hereby certify that by the affirmative vote of not less than sixty-seven percent (67%) of the unit owners which was sufficient for approval at the annual meeting of the members convened on January 11, 2003 and re-convened on January 20, 2003, held in accordance with the by-laws of this Association, the following amendment to the Articles of Incorporation was duly enacted:

**Article 1 of the Articles of Incorporation is amended to read as follows:**
